Answer: The Company announced to ASX on 25 June 2020 a proposed transaction involving the Koongie Park earn-in with Anglo Australian Resources NL. As part of that proposed transaction, the Company intends to carry out a significant capital raising (estimated at \$6M) in late 2020. If successful (and subject to ASX requirements) this raising will provide the Company with sufficient funds to carry out intended future activities for the foreseeable future.
