Answer: The entity proposes to increase exploration activity over at least the next two Quarters in line with funds available after the current capital raise program is completed.	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: Yes, the entity will shortly complete a share placement to sophisticated and professional investors to raise a total of \$3.6M (\$2.9M now and a further \$700k after shareholder approval at the proposed AGM on 31 May 2022). In addition, the entity has just opened a rights issue entitlement offer for existing shareholders intending to raise a further \$3.5M. The shortfall under this offer is fully underwritten by Vert Capital Pty Ltd.

Answer:

Yes. The entity is expected to have sufficient funds from the capital raising activities outlined above, in order to carry out its stated business objectives.
