Answer: Yes. While exploration activities at Koongie Park have concluded (as the wet season period in the Halls Creek region continues) there is likely to be limited significant exploration expenditure until late March/early April. In the event of the proposed Tanzanian acquisition completing (late January 2023) it is proposed to commence activities immediately.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes. The entity proposes to complete a further T2 raising of approx \$2.2M immediately upon completion of the proposed Tanzanian acquisition. The entity is confident that the raising will be completed, subject to adverse market conditions.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: The entity believes that successful completion of the T2 raising as part of the Tanzanian acquisition will provide sufficient funds (with existing cash resources) to continue operations and meet business objectives.
