<p>Answer: No, the entity is expected to have reduced cash outlays for the time being due to the following:</p> <ol style="list-style-type: none"> 1) Further drilling at the Itigi uranium project in Tanzania will be undertaken only after assay results are received from the first phase of the program – these assays are not expected for 8-10 weeks 2) Proposed drilling at the Mkuju uranium project in Tanzania is expected to commence in early-mid August, pending access to an auger drilling rig that has been sourced from Ghana in Western Africa 3) Further feasibility study activity following up the recent Koongie Park Scoping Study is under current consideration and will be subject to availability of suitable consultants for the further work that is required. In addition, to the extent that feasibility work relies on further drilling at the Koongie Park deposits, the timing of that further drilling is subject to drilling rig availability 	

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The entity proposes to take steps during the next Quarter to secure additional funding for its proposed activities in Tanzania and Australia. These steps are expected to be successful based on support from the existing Board. The terms of any further raising will be dependent on the market conditions at the time. It should also be noted that the entity received its R&D refund from the ATO of \$256k in early July 2023, providing additional cash for proposed activities and working capital.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. The entity holds mineral project interests that are still well supported by investors in the broader market. As a result, the entity remains confident that it will be able to continue to meet its business objectives.
